

Dear Friends in Christ:

One of the items on the Presbytery Council's agenda at our most recent meeting was to consider our guidance to congregations concerning in-person, indoor worship.

There is promising news. The number of new cases is decreasing in many parts of our country, and new vaccines have proven to be effective. We are beginning to see some light at the end of what has been a very long tunnel.

At the same time, public health officials have cautioned us that we are not yet at the end of that tunnel. Vaccine availability does not meet the current demand. New variants of the virus are emerging, all of which are more transmittable, and some of which are also more deadly. We are urged to remain vigilant in exercising the public health recommendations that have been in place for months, such as wearing masks, maintaining physical distance, and avoiding indoor gatherings with persons outside our households. This is not the time to relax our standards.

Given these concerns, the Presbytery Council recommends that sessions and pastors of congregations continue to exercise extreme caution concerning decisions about indoor, in-person worship and other gatherings.

Again, please know that we are not directing session to make a particular decision; neither the Council nor the Presbytery has the authority to do so. We are, instead, expressing our concern for the congregations of this presbytery.

These decisions are difficult, to be sure. We are aware that this may be the second Easter when congregations will not gather indoors and in-person. In addition to the sense of grief and loss that pastors and people may feel, there are also practical concerns about how to observe the seasons of Lent and Easter. Here are a few resources:

We continue to long for and hope for the day when we will see one another with uncovered face, when we will be able to sing together and share a meal together, when we will be able to serve side-by-side. Most of all, however, we hope that we will continue to exercise sound judgement and strong faith, waiting on the Lord, who gives us all that we need in every circumstance.
